\$400.00 if the Registration Form and Payment are postmarked after July 1, 2010.

While Crescent Lake Bible Camp will make every attempt to provide reasonable accommodations for children with special needs, Crescent Lake Bible Camp will not accept children that are (1) of danger to themselves, (2) of danger to others, or (3) a disruption to the normal activities making it unreasonably difficult for other children to enjoy Crescent Lake Bible Camp programs. Any of the above reasons will be grounds for dismissal from Crescent Lake Bible Camp programs. Parents will be required to arrange transportation for campers removed from camping programs due to behavior; this includes off-camp programs and trips. We strongly recommend that you discuss any special conditions or circumstances involving your child with Crescent Lake Bible Camp staff prior to registration so that we can advise you as to whether we can make a reasonable accommodation for your child.

My child has permission to leave campgrounds with authorized camp staff for scheduled trips and outings. I give Crescent Lake Bible Camp permission to use any photos or video taken of me or my child for future promotions or publications. I understand that there will be no refund of Canteen monies; instead any leftover credit will be applied to the Crescent Lake Bible Camp Scholarship Fund.

The 2010 Discipleship Alive Camp is scheduled on the week of July 25 – 31, 2010. Check-In will take place on Sunday at 3:00 p.m. and Check-Out is on Saturday at 11:00 a.m. If you require special arrangements for arrival and departure times, please contact Crescent Lake Bible Camp.

The rates for the 2010 Discipleship Alive Camp sponsored by Allasso Ministries are:

\$300.00 if the Registration Form and Payment are postmarked before December 15, 2009.

\$330.00 if the Registration Form and Payment are postmarked before March 1, 2010.

\$350.00 if the Registration Form and Payment are postmarked before June 1, 2010.

\$375.00 if the Registration Form and Payment are postmarked before July 1, 2010.

\$400.00 if the Registration Form and Payment are postmarked after July 1, 2010.

This fee covers meals, lodging, transportation to and from the volunteer sites, basic arts and crafts projects and tubing and waterskiing fees. Campers are encouraged to bring additional funds for the Canteen and if they are interested in doing more advanced craft projects.

Payment must be made in full at the time of your registration. In your payment is a \$50.00 non-transferrable, non-refundable deposit to cover processing. Upon receipt of your completed registration, you will receive a Parent Information Package, including a Health Form, Canteen Price List, Skills Class options (if applicable) and other information to help you in your planning.

This form will not be processed unless completely filled out and accompanied by your payment. We gladly accept cash, checks, cashier check, money order or Discover / MasterCard / Visa.
